 2. That the GIA is Recurring in nature and the objective for which it is being released is as below: *The project development objective is to improve the information available to the Government Health Services and Private Health Care providers on a set of high-priority diseases and risk factors, with a view to improve on the ground responses to such diseases and risk factors.*
 3. That a separate assets register for the programme is maintained under seal & signatures of Head of the institution.
 4. That the remuneration of contractual staff may be paid, provided a provision for the same made in the State PIP and approved by the NPCC for the current financial year.
 5. That Monthly SoE and Utilization Certificate is sent to the SHS regularly.
 6.
