

The Grant-in-Aid is subject to the following conditions:

1. That the above sanctioned funds are exclusively meant for the remuneration of Computer Assistant engaged under Routine Immunization (NHM) at state level, strictly as per the same rates, terms & conditions contained in the Budget Sheets and as per guidelines issued by the MoH&FW, GoI after observing all codal formalities required under rules.
2. That the Directorate should be registered as agency on PFMS portal to enable this office for release of funds under NHM in future as per the conditionalities of MoH&FW, GoI.
3. That further in view of the Aadhaar Act 2016, Aadhaar Number being mandatory to receive Social Welfare Benefits. The Programme Management Unit of your directorate shall ensure 100% Aadhaar seeding of all Contractual Staff engaged under NHM at the earliest, failing which funds shall not be released for the same in future.
4. That the proper record of Bank Column Cash Book, Ledger, Assets and other relevant record are to be maintained so that same is checked by any visiting team Central/State Govt.
5. That the statement of expenditure and utilization certificates are to be sent to the State Health Society regularly.
6. That the account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the ministry of Health & Family Welfare, Government of India, whenever the grantee is called upon to do so.
