In reference to additional DPR submitted by the Medical Superintendent, Govt. Hospital, Gandhi Nagar, Jammu vide letter No.GNH/J/2724-26 dated 1/1/2018 and as per ther approval of Executive Committee, SHS J&K, sanction is hereby accorded to release of additional Grant-in-Aid of **Rs.1.16 Lac (Rupees One Lac and Sixteen Thousand only)** under Mission Flexible Pool for setting up of Dialysis unit at Govt. Hospital, Gandhi Nagar, Jammu.

Accordingly, the above sanctioned GIA is hereby electronically transferred into the official **Bank A/c No.SB-47142** of Director Health Services, Jammu with the J&K Bank Ltd, Shalamar Road, Jammu for its further placement to the Medical Superintendent, Govt. Hospital, Gandhi Nagar Jammu

The Grant-in-Aid is sanctioned subject to the following conditions:

1. That the above sanctioned funds are exclusively meant for carrying out civil & electric works at Govt. Hospital, Gandhi Nagar, Jammu for installation of Dialysis Machines in the hospital under NHM strictly as per requirement and specifications of M/s Fair Fax India.
2. That no diversion of funds is permissible without approval of the Competent Authority.
3. That the Directorate shall accept the funds on PFMS portal after confirming the same from its bank account and subsequently release funds to the Districts/Implementing/Executive Agencies immediately through the said portal/e-transfer under intimation to the State Health Society, J&K.
4. That the sanctioned funds are to be utilized strictly as per the approvals issued by the MoH&FW, GoI and after observing all the codal formalities required under financial rules.
5. That the Physical/Financial achievements along with Statement of Expenditure & Utilization Certificates are to be sent to the State Health Society regularly
6. That all the structure/buildings supported under NHM shall have to prominently display the Logo of NHM in English, Hindi and regional languages.
7. That the proper record of Bank Column Cash Book, Ledger, Assets and other relevant records should be maintained at all levels for the check of any visiting team Central/State Govt. team.
8. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Office of the Ministry of Health & Family Welfare, Government of India, whenever the society is called upon to do so.
