For and on behalf of the Governor of Jammu & Kashmir State, sealed quotations are invited for whitewashing, including emersion paint for walls, pillars, etc. and enamel paint for iron grills, windows, doors, etc. in the office of State Health Society, National Health Mission, J&K – Nagrota, Jammu during the year 2016-17.

## **Terms & Conditions:**

- 1. General scope of work shall include white-washing of the main building premises of State Health Society, National Health Mission, J&K situated at Regional Institute of Health & Family Welfare, Near Sainik School, Nagrota, Jammu alongwith surrounding boundary walls, iron grills, windows, doors, etc.
  - a) Distempering of walls and roofs;
  - b) Painting of Windows, doors, iron grills, etc.;
  - c) Application of wall-putty
- 2. Successful contractor has to arrange all necessary materials required for execution of work.
- 3. Before submission of the rates, contractors are advised to make themselves fully conversant with the conditions and all other relevant information so that no ambiguity may arise in these respects subsequent to the submission of the rates.
- 4. By submitting rates, contractor will be deemed to have satisfied himself by actual inspection of the site and locality of the work, if so required, and that the rates quoted by him in the tender will be adequate to complete the work in all respects according to the specifications and other conditions and that he has taken into account all conditions and difficulties that may be encountered during its progress whether or not expressly provided in the notice inviting rates but necessary for the completion and maintenance of this work to the entire satisfaction of State Health Society.
- 5. SHS reserves to themselves the right of accepting the whole or any part of the quotation and contractor shall be bound to perform the same at his quoted rates.
- 6. No escalation is payable under this contract.
- 7. Rates quoted should be Net (inclusive of taxes).

- 8. Interested contractors shall have to submit duly signed quotation, in sealed cover, in the office of Mission Director, NHM, Regional Institute of Health and Family Welfare, Near Sainik School, Nagrota, Jammu 181221 by 18<sup>th</sup> November, 2016 upto 2.00 PM. Quotations shall be opened on the same day at 4.00 PM in the presence of the bidders who wants to remain present for the same.
- 9. Quotation received after due date & time, those received without separate sealed cover and rates not quoted in specified format will not be accepted.
- 10. Conditional quotations will not be accepted.
- 11. Quotations by Telex/ Fax/ e-mail/ Courier will not be accepted. Quotations shall have to be submitted in the office of SHS in person only.
- 12. No advance payment shall be made in any case.
- 13. In case successful contractor backs-out of the contract without explicit consent of SHS, he will be liable to recovery at higher rates which may have to be incurred by SHS on maintenance of computers/ peripheral items for the balance period of contract through alternative means. The said act of backing out would automatically debar the firm from any further dealing with SHS.
- 14. SHS reserves the right to accept or reject any or all quotations without assigning any reasons.
