- 1. That the above sanctioned GIA is exclusively meant for strengthening of Infrastructure & Laboratory for Health & Wellness Centres in aspirational in districts Kupwara and Baramulla of Kashmir Division under NHM in the State. - 2. That the funds are to be utilized in consultation with the District Development Commissioner of Kupwara & Baramulla districts as per the directions of Principal Secretary to Govt. Health & medical Education Department conveyed in the meeting regarding aspirational Districts at Civil Secretariat, Srinagar.
- 3. That the Directorate shall accept the funds on PFMS portal after confirming the same from its bank account and subsequently release funds to the Districts/Implementing Executive Agencies immediately through the said portal/e-transfer under intimation to the State Health Society, NHM, J&K and also ensure expenditure be uploaded on PFMS Portal.
- 4. That no diversion of funds shall be made without approval of competent authority.
- 5. That the funds are to be utilized after observing all codal formalities required under financial rules and strictly as per the guidelines issued by the MoH&FW. GoI in this regard.
- 6. That the procurement of drugs, consumables & equipments is to be made through J&K Medical Supplies Corporation Ltd or as per the instructions conveyed by the Administrative Department from time to time.
- 7. That the monthly Statement of Expenditure and Utilization Certificates are to be sent to the State Health Society.

- 8. That all the infrastructure/ equipments supported under NHM should prominently carry NHM Logo in English, Hindi and regional languages.
- 9. That the proper record of Bank Column Cash Book, Ledger, Assets Register and other relevant records are to be maintained for inspection of any visiting team from Central/State Government.
- 10. That the accounts of the grantee/organization shall be open to the inspection by the sanctioning authority and audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI, whenever the grantee/Society is called upon to do so.
