**Subject:** Termination order of State Accounts Manager (NUHM).

Whereas, Mr. Rahul Mahajan State Accounts Manager (NUHM) had proceeded on unauthorised absence from his duties from Divisional Office NHM, Kashmir without intimating his senior officers on 17-05-2018.

Whereas, two notices vide No. SHS/NHM/J&K/7442-44 Dated: 23-05-2018 and No. SHS/NHM/J&K/FMG/K/1292-94 Dated: 23-05-2018 were served on him from this office, asking the said officer to join his duties within 3 days and explain his position.

Whereas, despite the issuance of notices, the said officer turned a deaf ear and preferred to remain absent from duties, retaining all office records, equipments and Codes/Passwords of PFMS/DBT, thus hampering the functioning of the office (PFMS/DBT etc).

Whereas, various telephonic calls were made to the said officer by senior officers from Administrative Department and National Health Mission, in connection with urgent official work but he did not respond to the calls.



Whereas, a public notice Dated 13-06-2018, was issued through Print Media by this office, whereby a final opportunity was given to said officer to resume his duties at Divisional office NHM, Kashmir within 5 days from the date of publication of notice, but he failed to report, even after the expiry of time afforded to him.

Whereas, another notice vide No. SHS/NHM/J&K/10846 Dated: 29-06-2018 was issued in Print Media directing the said officer to handover office equipments, official records, codes/passwords of PFMS and DBT withheld by the said officer to FA&CAO, NHM, J&K, in the absence of which payments under various programmes were pending, thereby hampering overall functioning of the office, within 2 days from the publication of the notice.

Whereas, in view of afore mentioned events, the matter was referred to Learned Additional. Advocate General J&K High Court at Srinagar for legal opinion with regard to future course of action, who after detailed study of events and facts, suggested for immediate termination of said officer keeping in view the loss suffered by the department in the absence of officer in charge of the post.

Whereas, serious notice was taken by the Administrative Department, in view of pendency of payments under the programmes in charge of the said officer, and directions were issued to Mission Director NHM to initiate immediate action against the State Programme Manager (NUHM).

Hence with the approval of the competent authority, contractual service of Mr. Rahul Mahajan State Accounts Manager (NUHM) is hereby terminated with immediate effect.
