- 1. These funds are temporarily advanced by the State Health Society, NHM, J&K under Mission Flexipool and the same shall be recouped as and when funds are received either from the MoH&FW, Govt. of India or as State Share from the State Govt., whichever is earlier.
- 2. Funds shall be utilized strictly in accordance with the activities approved under RoP 2014-15 after observing all codal formalities required under the Rules and according to the Guidelines issued by the MOH&FW, Govt. of India which are available on the respective websites.
- 3. That a separate assets register for the programme is maintained under seal & signatures of the Head of the institution.
- 4. That the remuneration of contractual staff may be paid, provided a provision for the same had made in the State PIP and approved by the NPCC for the current financial year.
- 5. That Monthly SoE and Utilization Certificate is sent to the SHS regularly.
- 6. That the account of the District Health Society shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Officer of the Ministry of the Health & Family Welfare, GoI whenever the Society is called upon to do so.
